

# 2-YEAR LIMITED WARRANTY

#### What This Warranty Covers

Your Warranty covers defects in material and workmanship in Revisit Reverb Tanks purchased and serviced in the U.S.A. For units purchased and shipped to countries outside the U.S.A., the unit will be covered under warranty but the purchaser must pay for shipping both to and from our facility.

## What This Warranty Does Not Cover

The Warranty does not cover: (1) damage caused by accident, misuse, abuse, improper installation or operation, rental, product modification or neglect; (2) damage occurring during shipment; (3) damage caused by repair or service performed by persons not authorized by Studio Sound Electronics.

## Who This Warranty Protects

This Warranty protects only the original purchaser of the product.

## How Long This Warranty Lasts

The Warranty begins on the date of purchase by the original retail purchaser. The duration of the Warranty is 2 years.

## What Studio Sound Electronics Will Do

We will repair or replace (at Studio Sound Electronics' discretion) products covered by Warranty at no charge for labor or materials. As the product or component must be shipped to Studio Sound Electronics for Warranty service, the consumer must pay initial shipping charges. If the repairs are covered by Warranty, Studio Sound Electronics will pay the return shipping charges to addresses in the U.S.A. If the purchaser resides outside the U.S.A., purchaser will be responsible for return shipping costs.

## How To Get Warranty Service

Contact us via our website, <u>www.amprepairparts.com</u> for instructions on shipping. Ship the defective reverb tank, prepaid, to the address you are given in our correspondence. Include a description of the problem, together with a copy of your sales receipt or other proof of date of purchase as evidence of Warranty coverage. Also provide a complete return address. Tanks returned without a copy of the sales receipt may be denied warranty service, so always retain your sales invoice.

## **Limitation of Implied Warranties**

ANY IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED IN DURATION TO THE LENGTH OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

## **Exclusions of Damages**

STUDIO SOUND ELECTRONICS' LIABILITY FOR ANY DEFECTIVE PRODUCT IS LIMITED TO THE REPAIR OR REPLACEMENT OF THE PRODUCT, AT STUDIO SOUND ELECTRONICS' OPTION.
